## 2022 INTERACT AWARDS

## THEME

Each club must submit a video of the following theme. Only one Submission per club.

1. Use Rotary's new service-learning resources and show us your service-learning journey
2. or create a video of club events from July 1, 2021 to April 2, 2022
3. or the theme Serving to change lives
4. or one of the 7 areas of focus

## WHO

Any member of an Interact club or Rotary club that sponsors an Interact club may submit a video on behalf of their club. The parent/legal guardian of an Interactor ages 12-17 submitting a video must agree to these Submission Terms ("Terms") and complete the Interact Awards Form. By submitting a video you agree that you have the permission of your club. The Entry Form is also available in print form upon request by contacting Rotary International ("Rotary").

## WHEN

Nominations will be accepted until April 2, 2022 at 23:59 Vancouver Time.

## SUBMISSION REQUIREMENTS

- Your Submission must be your original creation;
- You must hold all rights to the Submission, including the copyright;
- If your video or photo includes images or likenesses of recognizable persons, you must receive written permission from the subject and the parent or legal guardian of any minors or individuals who lack legal capacity to i) record those people, and ii) use their likenesses/images and voices in the video.

- You must disclose to the subject(s) the purpose of the video or photo, and that Rotary will be using their image; and
- The welfare of a subject and the environment must be more important than capturing a video, and by submitting videos to Rotary, you certify the subjects were treated with respect and dignity, and that no people or wildlife were harmed and the environment not harmed in the creation.
- You must obtain property releases where required by the property owner;
- You must obtain releases or licenses when depicting other people's work in your Submission (such as logos, artwork, sculptures or other copyrightable work); and
- videos should accurately reflect the subject matter and the scene as it appeared.

### Submission Restrictions

- Videos may not have been previously published, exhibited, displayed, submitted or distributed to a third party and may not be pending publication;
- Submission must not contain material (images, music, footage, logos) that violates or infringes the rights of others, including, but not limited to, copyright, trademark or other intellectual property rights;
- Submission must not defame or invade the privacy rights or privacy of any person, living or deceased or contain defamatory materials; Submission must not contain advertising, nudity, partisan-politics, or other objectionable or inappropriate content and must not be insensitive, obscene, abusive, violent, hateful, harassing, discriminatory, unlawful or sexually explicit, as determined in Rotary's sole discretion;

All Submissions will become the property of Rotary and will not be returned.

Rotary will disqualify any Submission and entrant that do not adhere to these Terms.

### **HOW TO SUBMIT A VIDEO**

You must only submit one (1) video.

1. Create a [YouTube account](#) or log into your YouTube account. Follow YouTube's instructions for uploading your video to your YouTube account.
2. Complete and submit before 2 April 2022 at 23:59 Vancouver Time.

By submitting a video, you represent that your video is in compliance with these Terms, the [YouTube Terms of Service](#) and the [Facebook Terms of Service](#).

### **Video Requirements**

- Video must be at least thirty (30) seconds in length and may not exceed three (3) minutes in length;
- Video must be in English or contain English subtitles; and
- Video may only contain music you created or you have a license to use in the video. Any music license(s) you receive must allow for Rotary to use the video with the licensed music.

## **AWARDS**

- 3 prizes will be awarded
- 1st prize \$100.00, 2nd prize \$75 and 3rd prize \$50 that must be used to support an Interact club's service projects (The payment will be made to the Rotary club sponsor);
- A letter from the Rotary 5040 District Governor International President.
- Videos will be displayed on Interact's social media pages.

Any and all applicable taxes are the responsibility of the awardee of any payment. Rotary will notify the clubs receiving awards on or around 10 Apr 2022 and a club will have seven (7) days after notification to claim or forfeit the award. Failure to respond by 30 April 2022 will result in forfeiture of the award.

## **AWARD SELECTION**

All eligible videos will be reviewed by a the District Interact Committee and judged, based on storytelling ability, originality/creativity, execution, inspiration and adherence to the theme.

Submissions that do not comply with these Terms, in Rotary's sole discretion, will not be eligible for the selection process or an award.
